Here is the information that you requested on your upcoming marriage in September  
You must fully complete and return this information.

PLEASE RETURN NO LATER THAN SEPTEMBER 7, 2018.

Once you have completed the two (2) forms the Recorder will meet with the second party approximately one week prior to the wedding date. You will have already given the information to us and have helped us complete his part. All that he will have to do is show ID and check to make sure that all the information is correct. He will sign the application then and you will sign upon pickup of the Marriage License.

You will need to show up in person to pick up the Marriage License. The License will be ready for pick up the day before or the day of the ceremony. You will need to report to the Recorder of Deeds office to pick them up. That is when the \$51.00 in cash will be due. When you pick up the license, instructions will be given to you as to how the license is to be used. In most cases the Minister will know what to do in advance.

We are located in Downtown Charleston and directions are enclosed. Our office hours are 8am to 5pm Monday thru Friday.

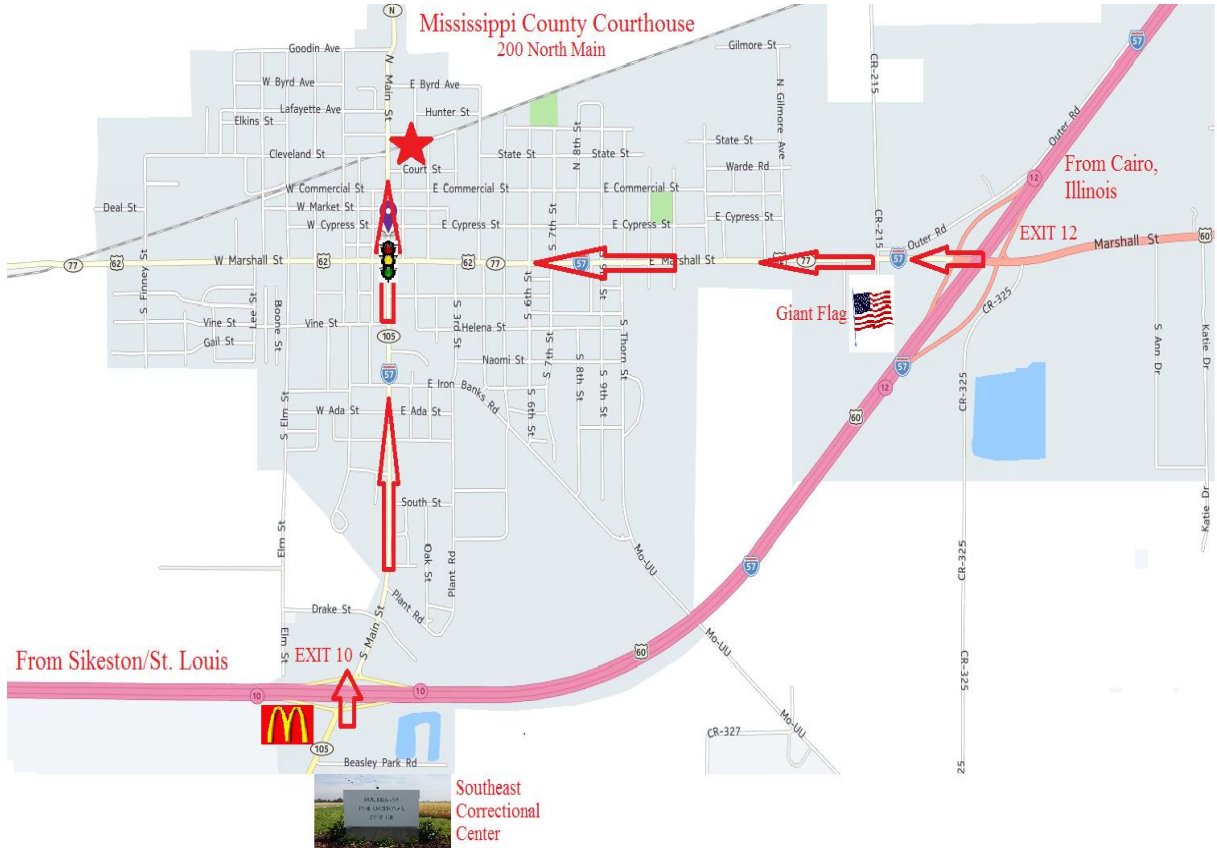

## **From Sikeston/St. Louis Area:**

Take Exit 10 (Boomland Exit) turn left onto South Main Street, go through two traffic lights. Road will narrow down to two lanes, go through next stop sign. The Mississippi County Courthouse will be two blocks on the right side.

## **From Cairo/Chicago, Illinois Area:**

Take Exit 12 (Flying J Exit) turn right onto East Marshall Street/US 62. Go to traffic light and turn right onto North Main. Go through next stop sign and Mississippi County Courthouse will be two blocks on the right side.
